Ralph Topping, the chief executive of William Hill, has called for "immediate and urgent" reform of the horse racing industry after the bookmaker's betting turnover fell 20pc on Saturday's Epsom Derby.

Mr Topping called for the flat season's blue riband event to be restored to Wednesday – or even another weekday such as Friday evening – when it faces much less competition from other leisure pursuits.

"How much more of a wake-up call does racing need before genuine reform takes

place?" asked Mr Topping. "That turnover means there was more interest shown on the Cheltenham Gold Cup – which is run on a Friday – than in the Derby, by a factor of nearly three."

He said the industry's Racing for Change programme lacked the necessary innovation.

A spokesman for the British Horseracing Authority hit back, saying: "What racing needs from Ralph Topping is some consistency and not just soundbites. We are trying to work with the betting industry on all manner of promotional initiatives. – That told him!

Paul Roy in the Racing Post – yawn



Paul Roy's Racing Post Interview, did anyone get any comfort from it? Why are other members of the BHA not battering the door down to get him out rather than electing him unopposed for a further term of office?

The answers of BHA chairman Paul Roy to questions in his Racing Post interview can be boiled down to just a few words – taken out of context (ed.) Taken in context and you'd never make it to the end. Much more of same in subsequent powder puff ATR interview.

Q: Does the might of the Levy Board and racecourses prove frustrating, particularly for a man with your financial expertise? (Give the interviewer a job).

A: It was the structure I inherited.

Q: The organisational structure makes the need for consensus unavoidable. Is that frustrating?

A: Nah (actually that IS definitely out of context – Roy didn't say it). Our style is to be independent and non-factional. We see our role as supporting and co-ordinating.

Q: Decision by consultation and consensus isn't conducive to quick or radical change. Doesn't it encourage decisions based on the lowest common denominator?

A: I will not allow the consultation process to get in the way of decisions (all the while "supporting and co-ordinating").

Q: But you don't control the decisions, do you?

A: We're not going anywhere if the BHA thinks it is in the wrong direction (sic and see above).

Q: You are a strong supporter and defender (there's a difference) of Racing For Change.

A: We've got the Crown Jewels of world racing...we haven't done enough in terms of promoting and branding...we're not very good at explaining or simplifying...we don't explain.

Q: Do you support the idea of an end-of-season championship finale?

A: I think the principle of having a finale day is a good one. The question is, what is its content? (eh?).

Q: Given the pressure on the levy, is there a case for the betting industry and racecourses funding integrity costs of fixtures staged largely for their benefit? (No, we aren't sure the question makes sense either).

A: If people want to put on additional fixtures, they are going to have to be funded from elsewhere.

Q: Racing has long argued that the betting industry does not pay a fair price for the product. What makes you think you can persuade the government to act when racing has failed in the past?

A: We'll wait and see what happens. (Roy is a member of the Levy Board asking for £135-£150m from the bookmakers. The likely figure is £77m. This is a "man with financial expertise").

Q: In practice, won't it be very difficult to force offshore bookmakers to pay levy?

A: There's going to have to be some legislation.

Q: What is your position on betting exchanges given that past governments have, in effect, accepted Betfair's arguments rather than those of bookmakers and racing?

A: The Treasury stated there wasn't sufficient evidence. If there isn't sufficient evidence now I don't know when there will be because it's staring you in the face. (What is? Ed).

Q: The Treasury clearly fears that, if exchange users are made to pay tax, it might open the door for gambling losses to be set against other income for tax purposes. Isn't that a big obstacle?

A: I know these people should be paying levy.

Q: Media rights income has grown. Do you think this will ultimately replace the levy system?

A: The levy is a secure and statutory mechanism.

Q: What is your position on the Tote?

A: There will have to be negotiations with government.
